The first driving lesson will be given within the month following enrolment in order to estimate the number of lessons corresponding to the level necessary to take the test. The estimation will be signed and dated by the student. And before going to any written or driving exam the student will do a trial test and must pass it. I f the official exam result is not good, there will be more or less 3 months waiting period before getting another exam date.	
The driving lessons consist of three phases: 1) Welcome and definition of the objective (about 10 minutes),	
2) The actual driving (about 45 minutes) and 3) evaluation (about 5 minutes).  With respect to obtaining a license, <b>the school</b> is only obliged to supply training for the student and not obliged to guarantee a result. The school may be obliged to cancel without any warning a test in case of overpowering circumstances (sick inspector) and

All driving lessons not <b>cancelled at least 48 hours</b> in advance must be paid unless there are justified overpowering circumstances.
